SCHOOL OPERATION Budget Update: – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment presentation for 2023. Enrollment update presented reflected a student count of 725 as of December 19th. Ahead of last year's pace. Of that total 550 students re-registered. Incoming students registered 191. Of that total 69 were incoming Kindergarten. The budget is based on a student count of 790.

Middle School Report:

ACADEMICS:

- Started conferencing with students and showing them how to log onto their Student Parent Portal
- ❖ Average daily student attendance is above 91%.
- ❖ Saturday School Applications have been distributed and are beginning to come in.
- ❖ The coaches and I are looking at the NYS assessment data to assist us in formulating a plan of action for Saturday school and test prep sessions. These sessions are scheduled to begin upon our return from holiday break.
- ❖ We have had 7 suspensions since the last Board report. This is 4 less than last school year around this time.
- Mentors and Mentor Coordinators received their certificates of completion on November 28. Ms. Foster will be meeting with the Mentor Coordinators and the Mentees on December 11 to discuss the program and the expectations.
- ❖ One of our newly hired TAs is proficient in sign language, Ms. Sheppard-Brooks. Ms. Sheppard-Brooks started teaching our fifth-grade students sign language. Students received sign language lessons once per week.
- ❖ Ms. Balunas has started their Girl Talk groups on Fridays.

ELA:

- ❖ In ELA, 5th Graders are continuing Module 1 which focuses on the essential question "What are human rights and how can they be threatened?" They have completed their character reaction paragraphs. They are utilizing the reaction paragraphs to write a compare and contrast essay.
- ❖ 6th Grade also continues with the first module that focuses on the Essential Question: What is mythology and what is the value of studying mythology from other cultures? Students compared and contrasted excerpts from the Percy Jackson novel with scenes from "The Lightning Thief" movie. Currently, students are creating a new character and rewriting a scene from The Lightning Thief that includes that new character and that is told from that character's point of view.

7th Grade concludes their first module with "A Long Walk to Water" a novel that

- ❖ focuses on The Lost Children of Sudan and their story. Students used graphic organizers to prepare for the end of unit assessment which is a comparative essay that compares and contrasts the novel "A Long Walk to Water" and "The Lost Girls of Sudan," which is an informational article.
- ❖ 8th Grade concludes their first module. The Essential Question is: Why do we see evidence of myths and traditional stories in modern narratives? As they continued to read "Summer of the Mariposas," students wrote a new scene for the book that is based on a modernized monster from Latin American folklore. For the end of unit assessment they are writing an essay that compares and contrasts the depiction of a monster in folklore from Latin America and in their modernized narrative.
- ❖ All grades have already begun to implement small-group instruction based on aggressive monitoring. The ELA team and coach have begun conferencing with students concerning their Iready Benchmark performance.

Math:

- ❖ In Math, 5th Grade is currently working on using strategies to divide by a two-digit divisor. 6th Grade is currently working on finding the quotients of problems involving multi-digit numbers. 7th Grade is currently working on turning fractions and mixed numbers into decimals and comparison of rational numbers to arrange them in order. 8th Grade is currently working on understanding the concept of slope and formula involved in its calculation given in a variety of ways.
- Currently the math teachers and I are conducting I-Ready math conferencing with the students based on their performance. I am currently monitoring my GradPoint students' performance and having conferencing when necessary. The coaches are preparing resources for Saturday School based on students' needs.

RTI

❖ CST meetings began after Thanksgiving Break, 27 Elementary school students were referred, and 11 middle school students were referred (38 SW)

86 students receive RTI services at the elementary school & 65 students receive RTI services at the middle school (151 SW)

- ❖ Cycle 1 will end on 12/8 for grades 4-8 and cycle 1 ends on 1/12 for grades K-3
- ❖ In Math we are using the Number Worlds curriculum for grade 4-8
- ❖ In Reading we are using both LLI & Achieve 3000
- ❖ The intervention curriculums we are using are research based and have yielded great results over the past few years, with many students graduating from the RTI program altogether. Students who remained in RTI showed wonderful improvement-we will have results for grades 4-8 before Christmas break.
- ❖ The Goal of RTI has and will continue to be to close the achievement gap, when little to no success has been achieved, we will refer students to the CST Team and if student still shows minimal progress, a special education evaluation will be the next step, with the consent of the child's parent.

RTI Teachers meet with Grade level teachers monthly to discuss progress and share notes on students' performance.

Special Education:

- Students are receiving resource room services as well as speech, counseling, physical therapy & occupational therapy.
- ❖ We are working more closely with our providers to ensure the academic and socialemotional success of our students.
- ❖ All teachers have received and reviewed their students' IEP and are aware of how the IEPs are to be implemented.
- ❖ We currently have 19 Elementary students with IEPs and 26 middles school students that have IEPs. 3 Elementary school students have 504 plans, and 6 middle school students have 504 plans (54 SW)
- ❖ A few students are currently not receiving services to date due to outside agency shortages and scheduling conflicts. Mrs. Johnson is working with the local district and agencies to get services started as soon as possible.
- Resource room and related service providers collaborate with Teachers on an on-going basis.

ENL Report:

❖ The ENL students have been working diligently during sessions. They continue to strengthen their listening, reading, writing, and speaking skills through varied activities provided by the ENL teachers. We will be exploring traditions and holidays that the students observe during this holiday season to expand cultural diversity among our ELL students.

SEL & Guidance Counsellor Report:

❖ High School Night- High School Night on November 30th was a success! Twenty-three families attended and enjoyed receiving information from the 6 high schools that attended.

8th Grade Work Study Program – We have now confirmed 16 students eligible for the 8th Grade Work Study Program. These 16 students have grades of 90 or higher in all core subjects and display exemplary behavior on a regular basis. Parents have received the information and are signing consent forms. Students are rotating through the following roles/responsibilities –

- ❖ Peer Mediation Team Members of our Peer Mediation Team will meet with Mrs. McGrath individually on Tuesday, December 12th. Our first meeting will include review of QTR 1 grades and behavior for each student. Students who have passed all classes for QTR 1 and practice positive behavior and good character on a regular basis will be able to remain as team members. After our initial meeting and establishing our team, students will begin mediating, promote the team by creating signs to be hung in the hallway and talking with all students about what we do and give conflict resolution tips.

Discipline Report:

- ❖ Teachers are responsible for creating, discussing, posting, and implementing the 7
 Restorative Core Values that will assist in creating and maintaining climate and culture in daily routines with students. The Core Values are Respect-Empathy-Judgement Free-Trust- Authenticity-Being Present- and Personal Victory. These Core Values will drive student social and emotional issues daily to ensure that instruction is enforced, and discipline is structured. This practice continues.
- * Restorative questioning must be reflected on all lesson plans including specials.
- ❖ Moments of Mindfulness meditation is scheduled every morning and afternoon to create a calm and community environment. We are working with some homerooms on implementing Restorative Practice techniques effectively. Mentors have been going into their Mentees classrooms to model in addition to the Dean and Guidance Counsellor. Working closely with eighth grade to restructure restorative practice and culture/climate restoration. Teachers are asked to be diligent in carrying out morning routines, being present in the hallways during transitions, and continuing phone calls home to parents. Additional focus is being put on gum chewing, foul language, and students staying in their own rooms and not wandering.

- Deans of Elementary and Middle School communicate via phone/in person to discuss issues of both schools.
- ❖ Dean held 9 Restorative Circles- 1 (8th Grade), 3 (7th Grade), 4(6th Grade), and 1(5th Grade).
- ❖ Teachers/TA's utilize Deans' List to record Parent Communication via phone, email, or text message. Administration strongly encourages phone calls. Five phone calls per day to communicate with parents/guardians. The Dean is currently assisting staff with Dean's List usage if need be.
- ❖ The Uniform Policy is being enforced daily with several checks throughout the morning. Calls are made when an infraction is found. RCA is going with logos!!
- ❖ Dean's List Blasts have been sent to parents and guardians for uniforms. This month it has been observed that students are wearing UGGs and tights instead of pants/slacks. Consequences follow for repeat offenders.
- ❖ The Community Service Program continues.
- ❖ 2 Parent Meetings were held.
- ❖ Dean's List Celebration for Quarter 1 for 85% and above in their core classes with exemplary behavior was held on Friday, November 17th in the gym. Dress Down for those students on Monday, November 20th, 2023, followed.
- Communication with administration is paramount. Dean communicates with Principal several times a day to discuss/review and creates strategies to make the middle school a safe and academically successful environment.

In terms of the IReady Diagnostic assessment, 35% of our students were performing at a level 3 or 4 at the time of the third Diagnostic assessment. We did have a 14% increase on the 2023 NYS Math assessment.

In the area of ELA, it is our goal is to have at least 45% of students performing at levels 3 and 4 in writing by the mid-year Benchmark assessment.

RCA serves as a rich source of field placement for Hofstra's teacher education and certification candidates (est. 2009). In exchange for these placements, Hofstra issues tuition credit vouchers to both cooperating teachers for use to take graduate courses and attend professional development programs and conferences. In addition, with tuition vouchers that are issued to the school, RCA actively and regularly engages professors and members of the School of Education faculty as consultants to develop programs, monitor and assess program effectiveness. With the tuition vouchers that are issued directly to the school, the RCA uses their value to offset the cost of using School of Education faculty as consultants on these projects.

2. Long Island University/Post: Ph.D. Clinical Psychologist: Fall Placements

Second Year Clinical Psychologist from LIU/Post facilitate interactive talks on mental health/mindfulness activities to educate elementary students, and in turn, learn from the unique experiences offered by the students. This symbiotic relationship has not only fulfilled academic requirements for LIU Post student. but has also contributed positively to the social and emotional learning for our Elementary students (including interactive talks on thoughts, feelings, behaviors, and mindfulness activities).

3. Elected Official Community Engagement Recognition:

Certificate of Recognition presented to Roosevelt Children's Academy Charter School (RCACS: Nassau County Legislator Kevan M. Abrahams certificate of recognition presented to RCACS.
