SCHOOL OPERATION Update: – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment and Approved Budget presentation for 2020-21. Enrollment update presented reflected 717 students that we are currently registered and will bill for September. The budget is based on student count of 630.
