SCHOOL OPERATION Update: – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment and Approved Budget presentation for 2020-21. Enrollment update presented reflected a student count of 578 as of July 28th. Of that total 552 students re-registered. Enrollment contacted families and 121students will not be returning. Parents contacted and re-registration continues, with safety protocols, until school reopens. Incoming K students registered 88 total incoming registered 155. Total registration for 2020-21 enrollment 707. The budget is based on student count of 630.

The Approved Budget for fiscal 2020-21 presented: Enrollment budgeted 630. Budgeted full year (FY) revenue is 12.5 million. Budgeted direct expenses \$9.4 million. Students are engaging in fun educational activities such as science experiments using household materials, reader's theater, interactive games, and small group instruction through the use of breakout rooms. The content that the staff is covering is based upon the recommendations of classroom teachers. They are reinforcing prerequisite skills needed for the grade level students will be moving on to in September.
- IV. The staff is remaining in contact with families with phone calls, mail, email, Remind, and Google Classroom. Weekly progress reports have been mailed out three times so far without any returns for incorrect/unknown address. There will also be a Parent Meeting Tuesday, July 28th at 9am, 12pm, and 6pm to continue to promote the expectations of summer school, explain how to navigate Google Classroom and Zoom, and allow parents to share any comments or concerns.
