SCHOOL OPERATION Update: – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment and Approved Budget presentation for 2020-21. Enrollment update presented reflected a student count of 710 as of November 20. Of that total 551 students re-registered. Incoming students registered 159. The budget is based on student count of 630.
