SCHOOL OPERATION Budget Update: – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment and Approved Budget presentation for 2021-22. Enrollment update presented reflected a student count of 762 as of August 24th. Of that total 573 students re-registered. Incoming students registered 189. Of that total 96 were incoming Kindergarten. The budget is based on student count of 665.

The Approved Budget for fiscal 2021-22 presented as of August 30th reflected total budgeted full year (FY) revenue is \$13.0 million. YTD recognized \$0.0 million. Revenue collections not yet started. Total budgeted (FY) direct expenses \$10.0 million. Spending YTD \$1.7 million. On target for FY spending. Total budgeted (FY) indirect expense is \$3.0 million. Spending YTD \$.4 million.
