SCHOOL OPERATION Budget Update: – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment presentation for 2021-22. Enrollment update presented reflected a student count of 692 as of July 19th. Ahead of the pace of last year with expectations for growth. Of that total 571 students re-registered. Incoming students registered 121. Of that total 89 were incoming Kindergarten. Ahead of the pace last year. The budget is based on student count of 665.

The Approved Budget for fiscal 2021-22 presented as of July 19th: Enrollment budget presented 665. Budgeted full year (FY) revenue is \$13.0 million. Budgeted direct expenses \$10.0 million. Budgeted indirect expense \$3.0 million.

Middle School Report:

ACADEMICS:

- ❖ About 91% of the 8th grade Algebra 1 students successfully took and pass the June 2022 Algebra 1 regents with a 65% or above. This is 21 out of 23 students. The two students who did not pass received a score of 64%. Since these two students passed the class and earned a Regents score between 50% and 65%, we can appeal the score to grant them credit for the Algebra 1 Regents. The school is the entity that grants the appeal, therefore we have earned a 100% passing rate.
- ❖ We are in the process of finalizing PD and ordering text and materials for the 2022-2023 academic year.
- ❖ Summer school officially started on Tuesday, July 5. We have 79 students enrolled in the program. Currently, we have about an 81% attendance rate.

- Students are assessed every one to two weeks depending on the pacing of the lessons. The data from the assessments are used to provide intervention in the areas where students struggled on the most. The intervention lessons are taught on Thursdays. The results of the assessments will be shared later.
- ELA and Math coaches are revising next year's pacing calendars, creating the open-ended benchmarks, revising the academic trackers, and creating ELA and Math competition. As a team, we will be meeting to finalize staffing, PD, scheduling, and Data teams.
- ❖ Earth Science: It is our plans to have a select group of students take the Earth Science Regents in June. To make this a reality it would require having a Saturday Class for 3 hours per class for 25 sessions. To host the class, we will need the following staffing: 1 teacher, 1 TA, and a security personnel. Estimated cost is \$6,000
