ROOSEVELT CHILDREN'S ACADEMY CHARTER SCHOOL

MOTION TO OPEN MEETING: Chair Rev Reginald Tuggle officially called the meeting to order at 6:03 P.M. A motion was made by DWashington, to open the Board Meeting. The motion seconded by Dr King-Cheek.

SCHOOL OPERATION Budget Update: – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment presentation for 2022-23. Enrollment update presented reflected a student count of 724 as of December 20th. Ahead of last year's pace. Of that total 542 students re-registered. Incoming students registered 182. Of that total 87 were incoming Kindergarten. The budget is based on student count of 700.

The Approved Budget for fiscal 2022-23 presented as of December 31st reflected total budgeted full year (FY) revenue is \$14.2 million. YTD recognized \$5.9 million. Total budgeted (FY) direct expenses \$10.1 million. Spending YTD \$4.6 million. Total budgeted (FY) indirect expense is \$4.1 million. Spending YTD \$1.9 million. On target for spending 100% of budget.

The Approved Budget for fiscal 2022-23 presented as of December 31st. 2022. Enrollment budget presented 700. Budgeted full year (FY) revenue is \$14.2 million. Budgeted direct expenses \$10.1 million. Budgeted indirect expenses \$4.1 million.





Middle School Report:

ACADEMICS:

- Teachers and Coaches are completing their conferences with students concerning their September iReady results. It is our hope that through these conferences and having students complete three ELA and Math iReady lessons per week we will see a drastic increase in their proficiency level.
- I have started conferencing with students about their report cards. It is my goal to conference with each fifth through eighth grade students prior to our holiday break. It is my goal to instill within our students the importance of their education, teaching them how to communicate with their teachers so that they will always know how they are doing academically, and helping them to develop proper work ethics. If all my time and efforts are successful, we should see an increase in academic performance.
- In December, we will fully implement the LEXIA English program with all of our Beginning ENL students in kindergarten through eighth grade. The TAs in our students' homeroom (Elementary) and English class (middle school) will be monitoring the students' online progress for LEXIA English three days per week. The TAs at middle school will conduct mini-instructional sessions using the print materials generated by the program once per week. All applicable TAs were trained on using program during our December 8 professional development.
- Planning for our first issue of the RCA Eagles continues to take shape. It is our hope that we will be able to publish our first issue prior to the end of Quarter 2.
- **Coaches and I continue to conduct weekly/bi-weekly walk throughs in math and ELA.**
- Mrs. Cralidis will continue to conduct classroom management walkthroughs with four of our teachers. We will be focusing on chapter 10, 11, and 12 of the Teach Like A Champion techniques to coach staff with developing effective classroom management skills.
- To assist the development of effective instructional strategies we have decided to implement class studies. Whenever mastery of effective instructional practices is observed the admin team and I will arrange a class study for teachers and TAs to observe instruction in the classroom. Then we meet to discuss the observations and takeaways. By so doing, we hope to duplicate effective

- instructional practices throughout the school thereby increasing academic performances amongst our students
- We hosted our first student mock trial on Friday, December 9. This is another step in our Restorative Practice. This strategy will allow students to hold each other accountable and hopefully assist each other in working through the issues that resulted them in making poor choices. Students also get the opportunity to have their voices be heard and understand what they have to say matters.
- In ELA, all grades are finishing their first module and preparing for the next module. 5th Grade is closing their first module with writing and revising a monologue based on a character's reaction to an event from Esperanza Rising. Students also include a director's note in which students write about the human right challenged by the event described in their monologues, identify the corresponding article from the UDHR, and explain how people are impacted by this issue today.
- 6th Grade culminates with the Greek Mythology module as students plan, write, and revise a scene from The Lightning Thief written from the perspective of a new character, who is the child of a Greek god. Students create a multimedia presentation explaining their narrative choice of Greek god and scene from The Lightning Thief.
- 7th Grade has finalized their first module with a revised narrative for third-grade elementary school students that tells the story of a Lost Boy or Girl of Sudan. They also create an illustrated eBook to accompany the narrative.
- Sth Grade wraps up their first module with students writing an informative essay comparing their modernized monster character to its original depiction in Latin American folklore. In addition, each student creates a webpage for their new scene and their essay.

- During December's PD, The ELA team utilizes a backwards planning template to become familiar with the content of their next module and the essential skills/standards to student success as they roll out upcoming lessons.
- In Math, 5th Grade is currently working on adding and subtracting decimals. 6th Grade is currently working on changing units of measure in the customary system. 7th Grade is currently working on adding and subtracting like fractions. 8th Grade is currently working on Unit 2: Expressions and Equations Assessment. Algebra 1 is currently working on Unit 2: Textbook Chapter 5: Linear Inequalities Test
- The 3 new Math Support Teachers will team teach with the lead teacher. They will be assigned 5 to 6 level 2 students per class, which equates to 15 to 18 students per grade. They will consistently work with the same students throughout the year with the goal of elevating them from level 2 to level 3.

<u>RTI</u>

- ***** The 2nd cycle began on November 28th.
- In Reading, students are continuing the LLI program as well as Achieve 3000. In Math students are using the McGraw Hill Number Worlds Intervention program.
- Cycle 1 growth is as follows:
 - ✓ Grade 1: 6 students remained the same, 18 students grew 1 level, 7 students grew 2 levels
 - ✓ Grade 2: 4 students remained the same, 9 students grew 1 level, 10 students grew 2 levels, 1 student moved up 3 levels
 - ✓ Grade 3: 6 students remained the same, 12 students grew one level, 1 student grew 2 levels
 - ✓ Grade 4: 11 students grew 1 level, 0 students grew 2 levels, 5 students remained at the same level
 - ✓ Grade 5: 6 students grew 1 level, 6 students remained at the same level.

- ✓ Grade 6: 2 students grew 1 level, 1 student grew 2 levels, 1 student grew 4 levels, 1 student grew 5 levels, 3 students remained at the same level.
- ✓ Grade 7: 3 students grew 1 level, 3 students grew 2 levels, 1 student grew 6 levels, 2 students remained at the same level.
- ✓ Grade 8: 3 students grew 1 level; 1 student grew 2 levels.
- Classroom Teachers have submitted pre-referrals for students who are making minimal progress with tier 1, 2 and 3 interventions.
- Child Study Team Meetings are wrapping up. 42 elementary students have been referred and 2 middle school students have been referred. So far, parents have been receptive to evaluations and will have to follow up with their districts to register and consent to evaluations. Since the recommendation has been for RCA to increase our SPED population, we are making a big push to ensure these evaluations take place but will need consistency and follow through from our parents. Ms. Johnson is working with families to provide the needed support.

Special Education:

- All students are receiving their related and academic services at this time. We have a new resource room Teacher who is providing Services for 25 students across the Elementary and Middle School.
- Parents and Teachers will be provided with quarter 2 progress reports in the coming weeks.
 The progress reports will provide insight on how students are progressing towards meeting their annual goals during the second academic quarter.

ENL Report:

The ENL department has been working with the students for four months. The students continue to make progress. The students continue to thrive and be engaged in a variety of activities during the lessons. The students enjoyed the completion of a holiday and cultural packet about Thanksgiving.

- Growth Mindset Wellness Celebration: All students in grades 5-8 will participate in Growth Mindset lessons/activities in all elective classes throughout the week of January 23, 2023. Guidance is working with Art, Music, Health, and PE as part of the Wellness Committee to plan these activities. The following subtopics are included in Growth Mindset are 1) Fixed Vs. Growth Mindset 2) Mistakes Help you Grow 3) Believe in the Power of Yet – "I can't do that...yet". 3) Psychologist Carol Dweck and Neuroplasticity 4) Pessimism Vs. Optimism 5) Keys to Motivation.

- Other Upcoming Wellness Activities
 - Light up the Night Fundraiser (Leukemia and Lymphoma Society School Fundraiser). School receives STEM resources and materials after the fundraiser)
 - ✓ Kids Heart Challenge
 - ✓ Wellness Walk/Special PE activity for the Spring
- GREAT Program for Grades 5 & 6: Grade 5 has started working with Officer Akingba from the NCPD. Officer Akingba is trained in implementing the GREAT Program, a violence prevention curriculum. Officer Akingba visited 5th grade on October 28th and is scheduled to implement his next lesson on 12/9. After completing a series of sessions with grade 5, Officer Akingba will go into the 6th grade classrooms. Some of the topics covered are as follows: decision making skills, effective communication, strategies for controlling anger, respect and being a "GREAT" citizen.
- STRONG Youth Program for Grades 7 & 8: We collaborated with STRONG Youth Organization and are scheduled for three motivational speakers to visit our 7th and 8th grade classes throughout the course of the school year. Speakers will be taking over Mr. Ellis's Social Studies classes for the day. So far, students engaged in one talk which was held on Tuesday, November 15. The topic covered was "Crabs in a Bucket", Cutting ties with people and places

- that will hold us back. Our speaker's name was Benjamin. Benjamin told students the story of his life and how it was negatively affected by peer pressure. Because he succumbed to negative peer pressure in his teens, he ended up spending 26 years in jail. Recently released from prison, Benjamin's mission is to help students realize how important it is for them to make positive choices for themselves and their futures. STRONG Youth is scheduled to return two more times this school year on February 15 and April 5.
- LI.U. SEL Workshops: Doctoral students from Long Island University completed their SEL Lessons with 5th grade classes on 11/21, 11/28 and 12/2. The workshops were successful, with students engaged and enjoying the presentation. The presentations covered the topics of thoughts, feelings, actions, and practical strategies for appropriately handling our emotions.
- Peer Mediation Team Our Peer Mediation Team and has been put to work and the program is continuing to gain momentum. Teachers receive a weekly email reminder that all student conflicts that involve 2-3 students should be referred to mediation. A goal of the program is for teachers to get into the habit of referring to mediation when necessary. So far, we have been practicing for 2 weeks and students have successfully completed 5 mediations. Each week, we wish to add more. I will continue to keep data and track the success of this program.
- College Day: It is my hope to incorporate a College Day for our middle school students in March. If some local colleges and universities can visit our school, the vision is to have a fair style event where the students can explore each college and get information. Possibly we can invite the parents to join us for this. Details TBD.
- School Counseling and Student Monitoring: Currently, 10 students are being seen weekly for school counseling sessions. Also, weekly student monitoring is competed with 16 students and addresses the students' feelings, review and reflection of recent behavior, behavior plan monitoring and review of academic progress. Dean and Guidance collaborate regularly on discipline issues, behavior plans, parent meetings and restorative practice.

- Restorative Modeling has been and will continue to be emulated in teachers' classrooms and in lesson plans.

- ***** Three Restorative Seventh Grade Restorative Circles were held in my office.
- ***** Two Restorative Eighth Grade Restorative Circles were held in the classroom.
- Moments of Mindfulness meditation are scheduled every morning and afternoon to create a calm and community environment. ***This practice continues and is going well.
- Meditation Room has been established as an extra support room for those students who need to reflect on behaviors that are Tier 1 behaviors. *** This room has not been utilized November into December as frequently as it was in the beginning of the school year. *** Behaviors are improving due to Behavior Charts and teachers dealing with Tier 1 behaviors within their classrooms.
- Harm Circle between one staff member and student will be held this Friday due to an issue in the bus room last week.
- Working with several staff members to ensure that students who have disciplinary issues and IEP's/ 504 Plans are receiving district mandates. Ms. Johnson and Ms. Ms. McGrath are assisting in this process.
- **A** Quarter One Dean's List Celebration was held.
- Coaching teachers within the classroom setting regarding discipline structures. This task has already started with the seventh-grade team. Several visits have been

- made with input that will be discussed with the teachers, Ms. Roberts, and team coaches. All information will be documented for resourcing purposes. *Teach Like A Champion* is the text that is utilized for PD purposes. This includes teachers reading chapters and viewing text videos, having relevant professional discussion regarding observation and what is expected of the teaching/discipline process. Discipline this month is *Procedures and Routines*.
- Teachers/TA's utilize Deans' List to record Parent Communication via phone, email, or text message. Administration strongly encourages phone communication. instead of text or email.
- The Uniform Policy is being enforced daily with several checks throughout the morning. Calls are made when an infraction is found. Dean's List messages are sent out to remind parents of infractions found within student body.
- The Community Service Program continues. Students are working with Ms. Longo on the Holiday Concert and with Dean Cralidis on the Coat Drive.
- Dean and Guidance Counselor have been hosting parent grade level meetings as part of Restorative Parent Communication. These meetings are facilitated to assist parents with their students when discipline issues arise. Goal and Behavior Contracts can be created from meetings if needed. *** This practice continues. In the month of December there have been 14 parent meetings. All successful.
- Communication with administration is paramount. Dean communicates with Principal several times a day to discuss/review and creates strategies to make the middle school a safe and academically successful environment.
